- iii. Co-option – Mrs Sackett was not present at the meeting and members agreed to move the co-option to the next meeting.
- iv. BT Phone Box – The BT phone box is installed at the pub but there are issues with the lighting, when the pub re-opens members would like to discuss the option of having a defibrillator installed in the phone box, this would need the

agreement of the pub for the electricity supply.

- v. Swallow Farm campsite – Residents who neighbour Swallow Farm have had notification that the site have applied to be classified as a certified campsite with Freedom Camping, the planning department have confirmed that a planning application is not required as long as the site operates within the rules for certified sites. Residents affected are advised to raise their concerns directly with Freedom camping.
